

RESOLUTION NO. 15-442

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENIFEE, CALIFORNIA, DESIGNATING THE TIME, DATE AND LOCATION OF CITY COUNCIL MEETINGS AND DESIGNATING LOCATIONS FOR POSTING AGENDA

WHEREAS, the City of Menifee was incorporated on October 1, 2008, as a general law city of the State of California; and

WHEREAS, state law required that at the time of incorporation, the City set the time, dates, and location of regular City Council meetings; and

WHEREAS, state law also required that the City adopt a resolution designating at least three (3) locations for posting of agendas, ordinances and/or resolutions required by law to be posted or published as well as establish an address for receipt of mail; and

WHEREAS, the City complied with the aforementioned requirements through its previous adoption of Resolution No. 13-332; and

WHEREAS, the City Council has directed that regular meetings of the City Council not be held in the month of July, which necessitates a revision to the regular meeting schedule specified in Resolution No. 13-332.

NOW, THEREFORE, the City Council of the City of Menifee does resolve and order as follows:

SECTION 1. TIME, DATE AND LOCATION OF REGULAR CITY COUNCIL MEETINGS. The regular meetings of the City Council shall be held at 6:00 p.m. for meetings that include a study session or closed session as necessary, and 7:00 p.m. for all other regular business meeting, on the first and third Wednesday of each month, unless the same shall be a legal holiday, in which case the regular meeting shall be held on the next succeeding day; provided, however, that no regular meetings of the City Council shall occur in the month of July.


SECTION 2. POSTING PLACES. All agendas, ordinances and resolutions required by law to be published or posted shall be posted in at City Hall and in at least three (3) public places within the City of Menifee in accordance with the provisions of Government Code Section 36933, which locations are as follows:


