

ORDINANCE NO. 2015-169

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MENIFEE, CALIFORNIA, AMENDING SECTION 080 "TIME, DATE AND LOCATION OF REGULAR MEETINGS," OF CHAPTER 2.30 "PARKS, RECREATION AND TRAILS COMMISSION" OF TITLE 2 "ADMINISTRATION AND PERSONNEL" OF THE MENIFEE MUNICIPAL CODE TO AMEND PROVISIONS ESTABLISHING THE TIME, DATE, AND LOCATION OF REGULAR MEETINGS OF THE PARKS, RECREATION AND TRAILS COMMISSION

WHEREAS, on April 16, 2014, the City Council of the City of Menifee ("City") adopted Ordinance No. 2014-143 which added Chapter 2.30 to the Menifee Municipal Code providing for a Parks, Recreation and Trails Commission ("Commission"); and

WHEREAS, on February 4, 2015, the City Council of the City of Menifee ("City") adopted Ordinance No. 2015-163 which amended Chapter 2.30 to the Menifee Municipal Code, to increase the frequency of modifying the frequency of Commission meetings; increasing them from one meeting per month to two meetings per month; and

WHEREAS, Since adoption of Ordinance Nos. 2014-143 and 2015-163, it has come to the attention of the City that members of the Commission desire to adjust the Commission meeting dates from the second and fourth Thursdays of each month to the first and third Thursdays of each month.

NOW THEREFORE, the City Council of the City of Menifee does hereby ordain as follows:

SECTION 1. Section 080 "Time Date and Location of Regular Meetings" of Chapter 2.30 "Parks, Recreation and Trails Commission" of Title 2 "Administration and Personnel" of the Menifee Municipal Code is hereby amended to read in its entirety as follows:

"§ 2.30.080 Time, Date and Location of Regular Meetings

The regular meetings of the Parks, Recreation, and Trails Commission shall be held at 6:00 p.m., on the first and third Thursdays of each month, (unless the same shall be a legal holiday, in which case the regular meeting shall be held on the next succeeding day or on another day as determined by the Commission and posted) at the City Hall at 29714 Haun Road, Menifee, CA 92586."

SECTION 2. Except as set forth in Section 1 of this Ordinance, Chapter 2.30 "Parks, Recreation and Trails Commission" of Title 2 "Administration and Personnel" of the Menifee Municipal Code remains unchanged and in full force and effect.

SECTION 3. This Ordinance No. 2015-169 is hereby adopted in accordance with all procedures set forth in Government Code Section 50022.2-50022.7 and in accordance with all other procedures required to adopt or re-adopt existing provisions of law by reference.

SECTION 4. If any section, subsection, paragraph, sentence, clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such invalidity or unconstitutionality shall

not affect the validity or constitutionality of the remaining portions of this ordinance, it being expressly declared that this ordinance and each section, subsection, paragraph, sentence, clause and phrase thereof would have been adopted, irrespective of the fact that one or more other section, subsection, paragraph, sentence, clause or phrase be declared invalid or unconstitutional.

SECTION 5. This ordinance shall take effect 30 days from the date of its adoption. The City Clerk shall certify to the passage of this ordinance and cause the same to be posted as required by law.
