**4. Update on Fire Station #60 in Canyon Lake**

City Manager Johnson reported on the various options that are being considered by the City of Lake Elsinore, Canyon Lake and County Fire. He noted he is attending a meeting on June 11, 2014 to hear an update on the various options being considered for fire service in Canyon Lake and how it will affect the various surrounding cities and County, and Station NO. 60.
