

**RESOLUTION NO. 22-1199**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENIFEE, CALIFORNIA, MAKING AN APPOINTMENT TO THE DISTRICT 4 CITY COUNCIL OFFICE AND CANCELLING THE NOVEMBER 8, 2022 GENERAL MUNICIPAL ELECTION AS IT RELATES TO DISTRICT 4**

**WHEREAS**, as of the close of the nomination period on August 12, 2022, there are not more candidates than City Council office for District 4 to be elected at the November 8, 2022 general municipal election; and

**WHEREAS**, Elections Code Section 10229 allows one of the following courses of action to be taken by the City Council:

1. Appoint to the office the person who has been nominated.
2. Appoint to the office any eligible voter if no one has been nominated.
3. Hold the election if either no one or only one person has been nominated; and

**WHEREAS**, a certification of the facts was submitted to the City Council on August 18, 2022, pursuant to Elections Code Section 10229; and

**WHEREAS**, a notice of these facts and the courses of action available was published on August 19, 2022, in a newspaper of general circulation pursuant to Elections Code Section 10229 and Government Code Section 6061.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MENIFEE, CALIFORNIA**, does hereby resolve, declare, determine and order as follows:

**Section 1.** Pursuant to Elections Code Section 10229, the following person is appointed to the office to which they were nominated:

<b>NAME</b>	<b>OFFICE</b>	<b>TERM</b>
Dean Deines	Councilmember, District 4	4 years

**Section 2.** The general municipal election for District 4, scheduled to be held on Tuesday, November 8, 2022, is canceled.

**Section 3.** The person appointed shall qualify and take office and serve exactly as if elected at a municipal election for the office.

**Section 4.** The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.


